THROUGH OUR HOMEOWNERSHIP PROGRAM, THESE FAMILIES - WHICH INCLUDE 33 ADULTS AND 35 CHILDREN - ACHIEVED STABILITY AND INDEPENDENCE. NEW CONSTRUCTION WAS CONCENTRATED IN BLIGHTED AREAS OF NORTHEAST WICHITA, LEVERAGING EXISTING INFRASTRUCTURE AND FOSTERING COMMUNITY REVITALIZATION.
